Sub: TNPCB - HWM - M/s. Emaar Lead Company Private Limited, SF.No.47 pt, Puliyamarathupalayam Road, Selakaraichal Village, Sulur Taluk, Coimbatore District - Direction under Section 5 of the Environment (Protection) Act,1986 issued for the violation of provisions of the Hazardous and Other Wastes (Management and Transboundary Movement) Rules, 2016 as amended - Regarding.

WHEREAS, You are operating a waste recycling unit utilizing waste lead acid batteries & lead wastes in the name of M/s. Emaar Lead Company Private Limited located at Puliyamarathupalayam Road, SF.No 47 pt of Selakaraichal village, Sulur taluk, Coimbatore district.

WHEREAS, Authorization under Hazardous and Other Wastes (Management and Transboundary Movement) Rules, 2016 has been issued to your unit vide reference first cited for handling of process hazardous waste items 9.1_lead bearing residues and 9.2_lead ash and also for receipt of waste lead acid batteries and lead wastes subject to compliance of certain conditions mentioned therein.

WHEREAS, during inspection of the unit on 26.09.2020 by TNPCB-HWM: Monitoring Team-3/CBE, the following violations/non compliances with respect to hazardous waste management were observed:-

- 1. The unit has furnished FORM-3 (records maintenance) wherein the quantity of generation & storage has not been entered and hence the actual generation of hazardous waste during 2019-20 could not be verified. The unit has not properly maintained FORM-III which is violation of Rule 6(5) of HOWM Rules, 2016 and also violation of the special condition (3) of Authorization granted vide Proc dt: 4.1.2018
- 2. The unit has furnished FORM-IV (Annual Returns) for the period 2019-20 and the details of hazardous waste recycled (Part-C) has not been furnished. Further, the quantity declared in the FORM-IV is not reflecting the actual generation of hazardous waste and disposal which is violation of Authorization granted vide Proc. dt 4.1.2018 and also violation of the special condition (4) of Authorization granted vide Proc dt: 4.1.2018
- 3. The unit is storing the process generated hazardous waste in improper manner without containment arrangement beyond 90 days which is violation of Rule 8 of HOWM Rules, 2016.

- 4. There is a mismatching in the quantity of hazardous waste generated when compared to production 2019-2020 as against the authorized HW quantity issued vide proc. dated: 4.1.2018 which is non compliance of the special condition (1) of Authorization granted under HOWM Rules, 2016 vide Proc dt: 4.1.2018.
- 5. Information of hazardous chemicals/wastes, air emission, effluent quality etc have not been updated on the HW display board installed at factory entrance which is a violation of the special condition (13) of Authorization granted under HOWM Rules, 2016 vide Proc dt: 4.1.2018 & the Hon'ble NGT(PB), New Delhi directions dated 26.08.2019 & 07.07.2020 in the OA No.804/2017.
- 6. The unit has not provided APC measures for the pit furnaces for the control of process emissions.
- 7. A new plastic crushing unit has been established without obtaining required permission (CTO-Exp) from Tamil Nadu Pollution Control Board which is a violation under TNPCB proc dated: 03.10.2020.

NOW, THEREFORE, in view of the above facts and in exercise of the powers delegated to TNPCB, under Section 5 of the Environment (Protection) Act 1986, you are hereby directed to show cause why financial penalty shall be levied as per Rule 23(2) of HOWM Rules, 2016 for the violations committed by the unit as mentioned and on the non-compliance of special conditions of Authorization granted under HOWM Rules, 2016 vide Proc dt: 04.01.2018. A reply to the show cause notice shall be furnished so as to reach to this office within 15 days from the date of receipt of this notice, failing which TNPCB will be constrained to initiate legal action as deemed necessary and appropriate in the circumstances under the Environment (Protection) Act 1986, as amended.

The receipt of the proceedings shall be acknowledged.
