The DLCCC decided to grant of Consent To Operate (CTO) to the unit of M/s. ABT Industries Limited, S.F.No: 163/1B1, 1B2 (Part),161/2B1C (part) & 161/2B (part), Sankaraperi Village, Thoothukudi Taluk & District under Section 25 of the Water (Prevention and Control of Pollution) Act, 1974 as amended and under Section 21 of the Air (prevention and Control of Pollution) Act, 1981 as amended for its Existing activity valid up to 31.03.2022 Subject to the following conditions:-

Category / Classification : (Orange / Small)

Water Act:

- The unit shall treat and dispose the sewage through septic tank & Dispersion Trench of adequate capacity.
- The unit shall treat the generate trade effluent through oil water separator provided and the treated trade effluent should satisfy the standards prescribed by the Board.
- 3. The unit shall dispose the solid waste generated then and there without any accumulation.
- The unit shall develop green belt to extent of 25% of total extent of land at a density of 400 trees
 //heotare.
- 5. This Consent under the Act shall not be construed as the Right to supersede or Overrule other Acts or Rules or Bylaws or Directions etc issued by other Government Department / Statutory Body / Local Body /Organization etc and the unit shall abide the same, as and when issued by the respective Authority.
- 6. The unit shall not use 'use and throw plastics' such as plastic sheets used for food wrapping, spreading on dining table ctc., plastic plates, plastic coated tea cups, plastic tumbler, water pouches and packets, plastic straw, plastic carry bags and plastic flags irrespective of thickness, within the industry premises. Instead unit shall encourage use of eco friendly alternative such as banana leaf, arecanut palm plate, stainless steel, glass, porcelain plates/cups, cloth bag, jute bag etc.

Air Act:

- 1. The unit shall adhere to the AAQ/ ANL Standards prescribed by the Board.
- 2. The unit shall not let out process emission in the promises.
- The unit shall develop green belt to an extent of 25% of the total extant of land with tree density of 400 trees/ Hectare.

- 4. This Consent under the Act shall not be construed as the Right to supersede or Oversule other Acts or Rules or Bylaws or Directions atc issued by other Government Department / Statutory Body / Lucal Body /Organization etc and the unit shall abide the same, as and when issued by the respective Authority.
- 5.
