Hence, it is Placed in the DLCCC Meeting and issue of Renewal of consent may be considered subject to the following additional conditions.

1. This Renewal is issued based on the previous records furnished by the unit.
2. The consent is issued based on the list of products with quantity and effluent/emission generation sources with details furnished earlier. For any variation in the above, the unit has to file application seeking fresh consent of the Board.
3. The unit shall not use "use and throwaway plastics such as plastic sheets used for food wrapping, spreading on dining table, plastic plates, plastic coated tea cups, plastic tumbler, water pouches and packets, plastic straw, plastic carry bag and plastic flags irrespective of thickness within the industry premises. Instead the unit shall encourage use of eco friendly alternatives such as banana leaf, areca nut palm plate, stainless steel, glass, porcelain plate/cups, cloth bag, jute bag etc.

**Additional conditions for plastic units.**

1. The unit shall not manufacture any banned plastic products as mentioned in G.O (Ms).No. 84 of Environment and Forest department dated 25.06.2018.
2. The unit shall comply with the guidelines dated 22.01.2019 issued by the Board.
3. The unit shall apply for plastic registration under Plastic Waste Management Rules 2016.
